INDICTMENT

The Prosecutor of the International Residual Mechanism for Criminal Tribunals (“Mechanism”), pursuant to his authority stipulated in Articles 1(4)(a), 14(1) and 16(4) of the Statute of the Mechanism (“Statute”) and Rule 90 of the Rules of Procedure and Evidence of the Mechanism (“Rules”), charges:

with **CONTEMPT OF THE INTERNATIONAL CRIMINAL TRIBUNAL FOR
THE FORMER YUGOSLAVIA AND THE MECHANISM** as set forth below:

THE ACCUSED

1. **Vojislav ŠEŠELJ** was born on 11 October 1954. **Vojislav ŠEŠELJ** is the President of the Serbian Radical Party (*Srpska Radikalna Stranka*, “SRS”) and he has served in various political positions in the Republic of Serbia and the Federal Republic of Yugoslavia. **Vojislav ŠEŠELJ** co-founded the publishing company *Velika Srbija* d.o.o. (“*Velika Srbija*”) and was a majority shareholder thereof until 30 November 2020. **Vojislav ŠEŠELJ** was convicted of crimes against humanity by the Mechanism and was convicted of contempt three times by the International Criminal Tribunal for the former Yugoslavia (“ICTY”).

2. **Miljan DAMJANOVIĆ** was born on 3 January 1984. **Miljan DAMJANOVIĆ** is a Vice-President of the SRS and a former member of the National Assembly of the Republic of Serbia representing the SRS. **Miljan DAMJANOVIĆ** is the owner of the webhosting account under which the website www.ictycaseseselj.com was registered.

3. **Miroljub IGNJATOVIĆ** was born on 27 August 1976. **Miroljub IGNJATOVIĆ** is a member of the SRS Executive Board and served as its President from 2018 to 2020. He has also been the Director of *Velika Srbija* since July 2016. **Miroljub IGNJATOVIĆ** is the owner of the webhosting account under which the website www.vseselj.rs was registered. From 2007 to 2019, **Miroljub IGNJATOVIĆ** was a member of the “expert team” assisting **Vojislav ŠEŠELJ** in proceedings before the ICTY and the Mechanism, including during contempt proceedings.

4. **Ljiljana MIHAJLOVIĆ** was born on 5 September 1965. She is a long-time member of the SRS and serves as **Vojislav ŠEŠELJ**'s chef de cabinet. She is a former member of the National Assembly of the Republic of Serbia representing the SRS. **Ljiljana MIHAJLOVIĆ** was a shareholder in *Velika Srbija* from 31 January 2012 until 30 November 2020, and is the President of the Assembly of the Association “Committee for the Defence of Vojislav Šešelj”. From 2004 to 2019, **Ljiljana MIHAJLOVIĆ** was a member of the “expert team” assisting **Vojislav ŠEŠELJ** in proceedings before the ICTY and the Mechanism, including during contempt proceedings.

5. **Ognjen MIHAJLOVIĆ** was born on 6 October 1960. **Ognjen MIHAJLOVIĆ** is a long-time, prominent, senior member of the SRS. He is a former member of the

National Assembly of the Republic of Serbia representing the SRS. **Ognjen MIHAJLOVIĆ** served as the SRS's Director of the Publishing Sector. From mid-2012 to July 2013, **Ognjen MIHAJLOVIĆ** served as the Director and Legal Representative of the Association "Committee for the Defence of Vojislav Šešelj". From 2004 to 2016, **Ognjen MIHAJLOVIĆ** was a member of the "expert team" assisting **Vojislav ŠEŠELJ** in proceedings before the ICTY and the Mechanism, including during contempt proceedings.

INDIVIDUAL CRIMINAL RESPONSIBILITY

6. By their conduct described below, **Vojislav ŠEŠELJ**, **Miljan DAMJANOVIĆ**, **Miroljub IGNJATOVIĆ**, **Ljiljana MIHAJLOVIĆ**, and **Ognjen MIHAJLOVIĆ** are individually criminally responsible for committing contempt pursuant to Article 1(4)(a) of the Statute and Rule 90(A) for knowingly and wilfully interfering with the administration of justice, and for disclosing information in knowing violation of court orders, including orders for the protection of witnesses, and for failing to comply with court orders to cease and desist from the publication of confidential information, without just excuse, pursuant to 90(A)(ii) and/or 90(A)(iii).

7. Since 2009, **Vojislav ŠEŠELJ**, **Miljan DAMJANOVIĆ**, **Miroljub IGNJATOVIĆ**, **Ljiljana MIHAJLOVIĆ**, **Ognjen MIHAJLOVIĆ**, and others made available to the public through publishing, advertising, selling and otherwise distributing books containing confidential information, as particularised in Annex 1.

8. From on or about 23 April 2015 until on or about 19 December 2018, **Vojislav ŠEŠELJ**, **Miljan DAMJANOVIĆ**, **Miroljub IGNJATOVIĆ** and others made available to the public on the website www.ictycaseseselj.com books and videos of court hearings containing confidential information, as particularised in Annex 2.

9. From at least 25 March 2019 until approximately 22 January 2020, **Vojislav ŠEŠELJ**, **Miroljub IGNJATOVIĆ** and others made available to the public on the website www.vseselj.rs books, transcripts of court hearings and filings containing confidential information, as particularised in Annex 3.

10. From on or about 19 July 2011 until on or about 13 June 2023, **Vojislav ŠEŠELJ, Miroljub IGNJATOVIĆ**, and others made available to the public on the webpage www.scribd.com/user/83897388 books containing confidential information, as particularised in Annex 4.

11. **Vojislav ŠEŠELJ, Miljan DAMJANOVIĆ, Miroljub IGNJATOVIĆ, Ljiljana MIHAJLOVIĆ** and **Ognjen MIHAJLOVIĆ** have failed to comply with orders of the Mechanism to cease and desist from the publication of confidential information, as of the dates particularised in Annex 5.

CHARGES

By their conduct set out above, the Accused are responsible for the following crime:

COUNT 1

CONTEMPT OF THE ICTY AND THE MECHANISM

Vojislav ŠEŠELJ, Miljan DAMJANOVIĆ, Miroljub IGNJATOVIĆ, Ljiljana MIHAJLOVIĆ, and **Ognjen MIHAJLOVIĆ** are criminally responsible for committing **CONTEMPT**, punishable under Article 1(4)(a) of the Statute and Rule 90(A), 90(A)(ii) and/or 90(A)(iii) of the Rules.
