**THE TRIAL CHAMBER** of the International Residual Mechanism for Criminal Tribunals (“Trial Chamber” and “Mechanism”, respectively);

**NOTING** the “Decision on Uwinkindi’s Request for Revocation”, issued by the Trial Chamber on 22 October 2015 at 12:42 h. (“Revocation Decision”), in which the Trial Chamber rejected Jean Uwinkindi’s request for the revocation of the referral of his case to the Republic of Rwanda;<sup>1</sup>

**BEING SEISED** of the “*Communication à la Chambre et au Procureur d’informations supplémentaires sur le dossier Uwinkindi Jean devant la Haute Cour (audiences du 15 et 20 octobre 2015)*”, filed by Uwinkindi on 22 October 2015 at 13:45 h. (“Supplemental Submission”), in which Uwinkindi seeks to supplement his submissions in support of his request for the revocation of his case;<sup>2</sup>

**NOTING** that the Prosecution has not filed a response;<sup>3</sup>


**CONSIDERING** that, in the Revocation Decision, the Trial Chamber has already adjudicated on Uwinkindi’s request for the revocation of his case<sup>4</sup> and therefore the proceedings before the Trial Chamber in relation to this matter have come to an end;
