On 1 July 2015, Jean de Dieu Kamuhanda ("Kamuhanda") filed a motion with the Mechanism for International Criminal Tribunals ("Mechanism") on the modalities for his Counsel to interview persons who have been granted protective measures in his case as part of investigations into possible new facts that may warrant a review of his conviction ("Motion").<sup>1</sup> Kamuhanda requests, principally, a decision allowing his Counsel to interview any protected person in his case who, through the Witness Support and Protection Unit ("WISP"), consents to the interview, or, in the alternative, authorisation to interview former Prosecution Witness GAE.<sup>2</sup>

2. On 7 July 2015, I was designated as Mechanism Single Judge to rule on the Motion.<sup>3</sup>

3. I find it prudent for the Prosecution and the Registrar to make submissions on the principal request identified in the Motion and submissions with respect to the alternative request, subject to the eventual consent of the Witness through WISP.

#### I, THEREFORE,

I. **INVITE** the Prosecution and the Registrar to make submissions on the present matter by 23 July 2015.
